Minutes

The meeting was called to order by Chairman Jerry Caamano, with fourteen members present; a quorum was met. Introduction of guests occurred. No media was in attendance.

The Treasurer's report was given and placed on file.

Report of the **Emergency Planning Coordinator**. Mr. Harold Damron updated and discussed the following:

- Virtual exercise hosted by the USEPA occurred in September; there were over 60 participants on the platform with wonderful participation by all.
- Senate Resolution 0982 recently was brought to the LEPC's attention; this resolution states that LEPC's should be partnering with local schools to identify storage or transportation of hazardous substances near their location.
- Ready Will County App is in the final stages of an upgrade and should be ready by the beginning of 2021.
- An upgrade to the current Incident Reports related to hazardous materials spills has been occurring over the past few months. Mr. Damron, along with Mrs. Anderson demonstrated the system, D4H, for members.

This concludes the report of the Emergency Planning Coordinator.

Report of the **Executive Board**. Chairman Caamano announced the Executive Board conducted a meeting via conference call to review and approve the agenda for today's meeting.

Report of the **Planning Subcommittee**. Report was given by Mr. Anthony Purefoy. Anthony informed the committee that in September all facilities were sent a reminder to update their Chemical Emergency Response Plans. As of 12/1/2020, 211 plans have been received by the LEPC. At this time the Committee has been reviewing plans for the southern part of Will County with the majority of plan reviews being conducted over the past few weeks via virtual platforms.

As of the close of business on 12/1/2020; there have been 74 spill reports generated (year-to-date).

34 of those reports were at a fixed facility

37 of those reports were transportation related

26 - Highway/Road vehicle

6 - Waterway

4 - Pipeline

1 - Railway

3 - Other

Year-to-date, there have been five (5) freedom of information requests.

Report of the **Public Information Subcommittee**. Chris Cleveland, Chair of the Public Information Subcommittee, reported that the PIO subcommittee has not had the opportunity to meet or have a training this year, due to the COVID-19 pandemic.
