MINUTES:

The meeting was called to order by Chairman Jerry Caamano, with seventeen members present. Introduction of guests presented occurred. Upon a motion by Chief Carl Churulo, seconded by Mr. John Cicero, the minutes from the previous meeting were approved as provided. The Treasurer's report was reviewed and upon a motion by Chief Dave Riddle, seconded by Mr. Tom Weigel the Treasurer's report was approved and placed on file for audit.

Report of the **Emergency Planning Coordinator**. Mr. Harold Damron spoke of the individual plan reviews that begin after this meeting today. All LEPC members were reached out to assist in this process over the next several weeks. Mr. Damron encourages all members, even if it is just a few hours to assist with the plan reviews.

Mr. Earl Mashaw, Project Manager, Regional Catastrophic Preparedness Grant who is with us today to speak on the subject. Mr. Damron mentioned that we have been doing this for years with our chemical emergency planning; now we are doing this more regionally for all hazards planning.

Will County EMA recently attended a successful pipeline exercise in Tinley Park through Exxon Mobil Pipeline. In May, 2011 we responded to a large butane pipeline incident in Romeoville and also in May, 2011 we responded to a smaller pipeline incident in Monee involving diesel, where a crack at the 90 degree turn occurred causing the release.

The 8^{th} Annual PIO Summit was held on June 20^{th} with more than 140 in attendance. A report will follow later in the meeting.

The grant for the Mobil Incident Command Center has been ordered. The grant which was applied for more than 3 years ago was approved. The new unit should be here in March. We hope to have it available to you at our next meeting.

Functional Needs Planning has been drawing more attention and brought to light lawsuits in New York and L.A. County, who's EOPs did not adequately cover the needs in their plans.

Codespear continues to operate and is being used more by our dispatch centers. We are appreciative of the continued financial support we receive from some of our regulated facilities and the Will County 9-1-1.

Community Emergency Response Team (CERT) held their annual challenge in early October. Congratulations to our Will County Health Department's Medical Reserve Corps who took $3^{\rm rd}$ place and New Lenox CERT who took $1^{\rm st}$ place.

Many of you have heard, November 9^{th} at 1pm CST the Nationwide EAS Test will occur. We have all heard tests being conducted periodically on various stations. This is the first time all components are being tested at the same time. Remember THIS IS ONLY A TEST.

In conclusion Mr. Damron asked if any members schedule allowed them to assist with the plan reviews, their time would be greatly appreciated.

This concludes the report of the Emergency Planning Coordinator.

Report of the **Planning Subcommittee**. Mr. Brian Rimbo echoed Mr. Damron in appreciation of member's assistance in the plan review process. Additionally, tier two reports were due March 1st, as of today all regulated facilities that are to submit are in compliance.

(Channahon); Crossroads Treatment, LLC (Bolingbrook); Echostar Broadcasting Corp. (Monee); GDC Logistics (Bolingbrook); Knead Dough Baking Company (Bolingbrook); Owens & Minor Distribution, Inc. (Tinley Park); Panduit Corporation, Raceway Systems Division (Lockport); Panduit Corporation Terminal Division (New Lenox); Peacock Engineering Company (Bolingbrook); Quantum Culinary (Bolingbrook); Salisbury Electrical Safety (Bolingbrook); Sunbelt Rentals PC #308 (Joliet); Total Logistic Control (Elwood); Triumph Packaging Group (Bolingbrook).

(Frankfort); Railway & Industrial Services (Joliet); RRR Tank Properties, LLC (Channahon); Saratoga Specialties (Bolingbrook); Vistar of Illinois (Woodridge).

Facilities with name changes include: GEA Westfalia Surge to GEA Farm Technologies, Inc.; INEOS Styrenics, LLC to Syrolution America, LLC; Kehe Foods Distributors to Kehe Distributors.

Facilities sold, include: M&E Distribution sold to Bolingbrook Cold Storage; the majority of Gas City's sold to Speedway, with a few sold to Shell; and Continental Refrigeration sold to Castle & Cooke Cold Storage.

Facilities that closed, include: Home Depot #5063 (Bolingbrook); Jacobson Warehouse (University Park); and, Prosource (Wilmington).

Chemical emergency preparedness plan reviews will start right after this meeting and continue through mid November. Many thanks to all who have given of their time to participate in the review process, it is greatly appreciated.
